## Certificate Description

Public Health has grown to encompass many disciplines and to focus on disease prevention in communities and across healthcare settings. The Graduate Certificate in Public Health Administration provides foundational skills and knowledge in working with local communities, government agencies and community-based non-profit agencies to develop health initiatives and evaluate their outcomes.

## Admission Requirments

Applicants are required to have an undergraduate grade-point average of at least 3.0 (on a 4.0 scale). Applicants with a cumulative undergraduate grade point average of 2.99-2.75 will be required to submit an official report of the Graduate Record Examination (General Test) scores for admission consideration.

## Certificate Learning Outcomes

1. Compare the organization, structure and function of health care, public health and regulatory systems across national and international settings
2. Discuss the means by which structural bias, social inequities and racism undermine health and create challenges to achieving health equity at organizational, community and societal levels
3. Assess population needs, assets and capacities that affect communities' health
4. Apply awareness of cultural values and practices to the design or implementation of public health policies or programs
5. Design a population-based policy, program, project or intervention
6. Explain basic principles and tools of budget and resource management
7. Select methods to evaluate public health programs
8. Discuss multiple dimensions of the policy-making process, including the roles of ethics and evidence
9. Propose strategies to identify stakeholders and build coalitions and partnerships for influencing public health outcomes

10. Advocate for political, social or economic policies and programs that will improve health in diverse populations
11. Evaluate policies for their impact on public health and health equity
12. Apply principles of leadership, governance and management, which include creating a vision, empowering others, fostering collaboration and guiding decision making
13. Apply negotiation and mediation skills to address organizational or community challenges
14. Select communication strategies for different audiences and sectors
15. Communicate audience-appropriate public health content, both in writing and through oral presentation
16. Describe the importance of cultural competence in communicating public health content
17. Perform effectively on interprofessional teams
18. Apply systems thinking tools to a public health issue
19. Prepare proposals for funding from external sources.
